## Overview

He has earned numerous dismissals of claims at the initial pleadings and summary judgment stages of litigation in addition to securing judgments in his clients' favor at trial, on appeal, and in private arbitration.

Mr. Gilday's transactional practice focuses on commercial real estate matters. He routinely drafts and negotiates construction contracts, commercial real estate broker listing agreements, and property management agreements.
