OVERVIEW

His innovative thinking is best illustrated by his success in obtaining a highly influential discovery ruling that permits simultaneous compliance with the requirements of the Federal Rules of Civil Procedure and the French Blocking Statute. Andrew prefers to build a partnership with each client that allows him to gain proper insight into the operation of their business, their tolerance for litigation risk, and their perception of the best available outcome. In appropriate circumstances, Andrew has helped implement pre-litigation investigations and settlement programs for clients facing product issues, allowing them to resolve their disputes and maintain their business reputation without proceeding to litigation or trial.

Andrew is actively involved in the global legal community. He was recently installed as President of the International Association of Defense Counsel (IADC), which is composed of the world’s leading corporate and insurance attorneys and insurance executives.
